Traditionally, Spain has been a country with a consistent level of emigration.

Since the discovery of America in 1492, this continent has been a very important destination for Spanish people looking for work or fortune.

In the second half of the XX century, the pattern of emigration shifted to a more dominant concentration in Europe.

Due to the crisis of 1973, the flow of emigrants decreased, and practically disappeared in 1986 with the incorporation of Spain into the European Community.

Through Spain's incorporation into the European Union, the country's recent history has been marked for its practically uninterrupted economic growth until this year.

This growth has produced a very prominent phenomenon of foreign immigration, which is absolutely new in Spain.




However, a social character law from the year 2000 helped to evaluate the dimension of migratory movement in Spain.


This law permitted free medical care and free access to the public education system for all residents in Spain without requiring proof of ones legal status.

In order to have these benefits, the only requirement is to be registered as a resident of Spain. This registry allows to count the foreigners residing in Spain in the last years.

This phenomenon has a great effect on the EGM.

In 1998 the technical committee of EGM confirmed that the object of the investigation is all the people that reside in Spain, including the foreigners, no matter where they came from.


In that year, there were 637,000 foreign residents in Spain, of which only 25% cames from Spanish speaking countries.

People from United Kingdom, Germany, France and Italy represent almost a third of this population. In the majority of the cases, these people are retired residents who live in tourist zones, with a low level of Spanish, and therefore cannot be interviewed.



Comparing EGM's annual data with the Registry average of the current year and the previous year



- The immigrant population is younger than the Spanish....






Structure of immigrants by age

CONCLUSIONS(I):

- The total size of immigrants is adequately represented in EGM.
- The distribution of immigrants from different countries of origin is not evenly represented.

CONCLUSIONS(II):

- In order to try to correct the nationality differences, we could need to carry out additional actions:
 - Interviewers with knowledge of other languages (How many languages is one interviewer required to know in order to question all nationalities?).
 - Use quota sampling for non Spanish nationalities (This methodology is inaccurate and expensive).
 - It is possible to use weighting procedures to adjust the representation of different nationalities.
